I recently spoke with the mother of an eight month old baby who found herself in the hospital on the weekend with no one to help her. Her child was bored and miserable but she didn't want to leave her daughter alone to go back to the shelter they were living in to get her baby's few toys.

Then she met our Child Life Specialist, Ivana, on Saturday morning, and soon heard the sound of her baby giggling and playing delightedly. They passed the day together in the playroom and she only left her daughter when the doctor wanted to consult with her. She was able to do this because Ivana willingly stayed with her child, allowing the mother to give her undivided attention to the doctor.

In our conversation, the mom shared with me, "Ivana was there at the most critical time, when I really needed someone. She wasn't just there for my baby, she was there for me, too. And not just as a counselor, but as a friend."
