Next, Maureen introduced a real stethoscope and demonstrated how to put it on and how it works. The girl was thrilled to have the opportunity to use a real doctor's tool. As she listened to her own heart, she was amazed and asked, "Is that really my heart that I hear?" She proceeded to listen to her parents' hearts as well, and then her teddy bear, as well as every doll in the playroom. She was satisfied with the health of all the dolls and declared, "Everybody's better!" Thanks to Maureen, and the proven model of using medical play, this little girl was able to overcome her fear of the doctor and of needles.
